### **Post-doctoral Teaching Fellow Sustainability Policy for Southern California**

Pitzer College is seeking candidates for a one year (with possible one semester extension), non-tenure track Post-doctoral Visiting Teaching Fellow position focused on policy formation to address community sustainability, environmental justice, the built environment, and access to and conservation of natural resources in Southern California. The position will begin August 15, 2015. The successful candidate will teach three courses over the year. *Among the potential policy areas that might be addressed in courses:*

- Regional Climate Adaptation Policy
- National and Regional Models for Sustainability Policy
- Air and Water Quality Policy/Regional Transportation and Land Use
- Regional Food and Agricultural Policy: Equity and Sustainability

Preference will be given candidates with experience in GIS and spatial underpinnings of sustainability policy analysis, planning or design. Modest financial support is available for associated research and outreach efforts with respect to GIS, especially work that touches upon for the six focus areas of resource conservation of the Redford Conservancy; <http://pitweb.pitzer.edu/redfordconservancy/>

Applicants must have a PhD degree (attained by date of appointment) in a field related to these policy areas. Fields pertinent to the position include but are not limited to Public Policy, Urban and Regional Planning, Geography, and Environmental and Sustainability Studies. Previous teaching experience is highly desirable. Candidates should submit a letter of application, including curriculum vitae, selected evidence of teaching accomplishment, course evaluations, a writing sample, and the names and e-mail addresses of recommendation providers.
