**Assistant or Associate Professor in the
Tenure Track, Research Track, or Clinical Teaching Track**

The Department of Environmental and Occupational Health in the Colorado School of Public Health (ColoradoSPH) invites applications for two positions at the Assistant or Associate Professor level in either the Tenure, Research, or Clinical Teaching tracks. We seek candidates with expertise in one or more areas of environmental or occupational health and related disciplines who are eager to become part of a vibrant, growing department.

We particularly encourage applicants with interests that address cross-disciplinary research in the fields of: Climate Change and Health; Dissemination and Implementation Science; Emergency Preparedness, Response and Resilience; Environmental Justice; Geospatial Methods; Total Worker Health, and/or Occupational Epidemiology, though applications from exceptional candidates in all areas of Environmental and Occupational Health will be considered. Innovative, cross-disciplinary and research to practice approaches are particularly valued. Competitive candidates for the tenure and research tracks will be emerging leaders in the field who have a track record of conducting independent research (Associate) or potential to develop an independent research program (Assistant). Successful candidates for the tenure and clinical teaching tracks will also have a demonstrated commitment to teaching excellence, and for the clinical teaching track, public health practice. All successful candidates will demonstrate a passion for mentoring.

Our Department's goal is to expand our multi-disciplinary faculty and our ability to conduct innovative, impactful research in Environmental and Occupational Health. The Department has several cutting edge research and education initiatives, including Impacts of Fossil Fuel Development on Human Health, the University of Colorado Consortium on Climate Change and Health, international research on both communicable and non-communicable diseases, and implementation research in Occupational Health and Safety, including two NIOSH-funded Centers: the Mountain and Plains Education and Research Center (MAP ERC) and the Center for Health Work & Environment, a NIOSH Total Worker Health Center of Excellence.

Interested candidates should submit a full CV and a letter of application letter that clearly states the track and rank for which the applicant is applying. The letter should address the corresponding job requirements and outline the applicant's qualifications. Applicants should also provide the names of three to five professional references.
